Contract for Stud Service

Katherine Branson, the owner of the below listed Stud Dog, enters into this agreement with the intent to help the Bitch Owner produce healthy puppies which, in both type and temperament, will be good representatives of the Australian Cattle Dog breed. To this end, the following items are included in this Stud Contract:

1. The bitch owner agrees to provide the stud dog owner with recent photos or videotape of this bitch (if unknown to the stud dog owner), a four generation pedigree, copies of all testing results (Hips, Elbows, CERF, prcdPRA, PLL, rcd4, BAER, etc.), and proof of all recent immunizations.
2. The Stud Dog owner agrees to provide the bitch owner with a full pedigree of the stud dog and copies of all his testing results results (Hips, Elbows, CERF, prcdPRA, PLL, rcd4, BAER, etc.).
3. The bitch owner agrees to provide current brucellosis test performed within 14 days of the expected breeding.
4. The stud dog owner guarantees that the above mentioned stud dog will be tested for brucellosis before breeding takes place.
5. The bitch owner guarantees that this Bitch has not been exposed to any other Stud Dog from the start of her heat cycle until the time of delivery to the stud dogs location.
6. Bitch owner is responsible for any and all fees associated with breeding, including, but not limited to veterinary Services, shipping fees, ovulation timing or artificial insemination fees.
7. The stud dog owner guarantees to make every attempt to contact the bitch owner before ANY veterinary care is rendered but in the case of an emergency, the bitch owner agrees that veterinary care and any emergency decisions can be made by the stud dog owner.
8. The bitch owner agrees to pay the stud dog owner a nonrefundable service fee of \$300.00 due when the bitch is dropped off for breeding. The balance of the stud fee, \$800.00, is due within 7 days of the resulting litter being whelped.
9. In the instance that the stud dog owner opts to choose a puppy from this litter, stud fee will be refunded in full upon receipt of the pup.
10. The owner of the Stud Dog guarantees that the bitch whelp two live puppies. If the Bitch fails to whelp or whelps less than two live puppies, the Stud Dog owner will provide one repeat stud service to this Bitch or a substitute Bitch owned or co-owned by the same owner. In the case of a substitute Bitch, all requirements of the original contract must be met (including service fee). In the case that the Bitch changes ownership, there is no obligation on the part of the Stud Dog owner to provide a repeat service.
11. The bitch owner agrees to provide the stud dog owner a list of names, addresses and phone numbers of the puppy buyers from the resulting litter. The bitch owner also agrees to provide the new puppy owners with the contact information for the stud dog owner.
12. Bitch owner agrees not to knowingly sell a puppy to a pet store, animal wholesaler or broker.
